

## Township of Cramahe Planning Fees

### **Consent (Severance and Lot Line Adjustment) Fees:**

Township of Cramahe:	\$1000 <sup>(1)</sup>
County of Northumberland Review Fee (Planning):	\$250 <sup>(1)</sup>
Lower Trent Conservation Authority:	\$410 <sup>(2)</sup>
County of Northumberland (Septic/Sewage):	\$500 <sup>(3)</sup>

**\*Please note:**

- A survey and deed will be required to complete the consent and all related fees must be paid by the applicant.

- A park levy fee of \$1100 per lot will be required as a condition of consent.

<sup>(1)</sup>TOWNSHIP & COUNTY – If costs are incurred by the Planning Agency to retain external professionals (i.e. solicitors, hydro geologists, engineers, etc.) to assist in the commenting or processing of an application(s), the associated costs will be directed back to the applicant for full recovery.

<sup>(2)</sup>LTC – If adjacent consent applications are being considered simultaneously, up to three applications may be covered by a single fee of \$615.

<sup>(3)</sup>COUNTY – If the parcel being created is under 10 acres (4.0 ha) or over 10 acres (4.0 ha) a fee of \$500 is required.

County of Northumberland Stand Alone(Septic/Sewage):	\$300

Lower Trent Conservation Authority:	\$305
County of Northumberland (Septic/Sewage):	\$300

- A survey may be required to complete the Minor Variance and all related fees must be paid by the applicant.

Amendment	\$940
County of Northumberland (Planning):	\$550 <sup>(2)</sup>
Lower Trent Conservation Authority:	\$510 or \$1530 <sup>(3)</sup>

<sup>(1)</sup> Plus 50% value of site construction cost, to be refunded after project is completed in accordance with Site Plan Agreement.

<sup>(2)</sup> TOWNSHIP & COUNTY – If costs are incurred by the Planning Agency to retain external professionals (i.e. solicitors, hydro geologists, engineers, etc.) to assist in the commenting or processing of an application(s), the associated costs will be directed back to the applicant for full recovery.

<sup>(3)</sup> LTC - If technical studies other than lot drainage and grading plans are required to be reviewed, the SPA is deemed 'major' and the fee will be \$1,530. If no technical studies other than lot drainage and grading plans are required to be reviewed, the SPA is deemed 'minor' and the fee will be \$510.
