

THE CORPORATION OF THE TOWNSHIP OF CRAMAHE
BY-LAW NO. BL-2023-33

Being a By-law to amend Schedule A of By-law 2022-70, to appoint members to various Committees and Boards within the Corporation of the Township of Cramahe.

WHEREAS subsection 5(3) of the Municipal Act, 2001, S.O. 2001, c. 25, as amended, provides that a municipal power shall be exercised by a by-law; and

WHEREAS subsection 10(1) of the Municipal Act, 2001 provides that a municipality may provide any service that the municipality considers necessary or desirable for the public; and


WHEREAS subsection 1 & 2 of subsection 10(2) of the Municipal Act, 2001 provides that a municipality may pass by-laws respecting the governance structure of the municipality and its local boards and the accountability and transparency of the municipality and its operations and of its local boards and their operations; and

WHEREAS the Council of the Corporation of the Township of Cramahe deems it expedient to appoint members to various Committees and Boards of the Municipality.


Now therefore be it resolved that the Council of The Corporation of the Township of Cramahe hereby enacts as follows:

1. **That** Schedule A of By-law 2022-70 be repealed and replaced with the attached schedule; and
2. **That** this by-law shall be deemed to be in force and effect as of the day of its passing.

Read a first, second and third time and finally passed this 25 day of April 2023.
