Property Taxation on Railway Right-of-Way's, correspondence from Fort Frances, dated January 10, 2017

"WHEREAS it has been identified that Railway Companies in the province of Ontario, do not pay a proportionate share of municipal property tax as compared to other properties in their class, or compared to any other municipal tax class; and

WHEREAS in other provinces and jurisdictions the railway companies do remit a more equitable share of taxes to the local tax base; and

WHEREAS taxes in other jurisdictions for railway properties are calculated using a ton-mile concept; and

WHEREAS said fees are reviewed and adjusted on a regular basis according to inflation and ongoing current conditions; and

WHEREAS the Province of Ontario has continued to fall further and further behind in their approach to railroad property taxation over the past 112 plus years;

THEREFORE BE IT RESOLVED THAT the Council for the Township of Cramahe call upon the Minister of Finance for the Province of Ontario to implement a new system of

municipal property taxation for rail road right-of-way properties based on utilizing a per ton-mile concept; and

FURTHER BE IT RESOLVED THAT the new tax system when implemented, be reviewed on a regular basis, similar to the MPAC four-year assessment cycle; and

FURTHER BE IT RESOLVED THAT this resolution be sent to every Municipal Council within the Province of Ontario seeking their support, the Premier of Ontario, the Minister of Finance of Ontario, Ontario MPPs, Local MPs, RRDMA, NOMA, AMO and FONOM."

Manager of Operations, Jeff Hoskin, advised Council that staff would be enforcing the overnight parking restrictions in the downtown area over the next while. Illegal parking on municipal roads is interfering with snow removal and while advertising has been done on the municipal website, newspaper block ad and information flyers placed on windshields, there are repeat offenders, with cars parked in the downtown, notably along Church and King Street. Jeff advised Council that there would be a "ticket blitz" for the illegal parking with a warning placed on the windshield that the car may be towed. If the car was towed, in addition to the set fine amount, it would be the owner's responsibility to pay impound fees that would include towing charges and storage before the vehicle could be retrieved.
