

## Notice of a Complete Application & Public Meeting Concerning a Consent D10-DAR-07-24

**TAKE NOTICE** that the Committee of Adjustment of the Corporation of the Township of Cramahe has received a complete application for consent (severance) and is notifying the public in accordance with Section 53 of the *Planning Act*.

#### **Location of the Subject Lands**

The lands subject to the proposed consent are located at 1580 Morganston Road and are municipally known as Part of Lot 17, Concession 9, Township of Cramahe (Assessment Roll # 1411 011 040 08300). A key map is attached showing the location of the Subject Lands.

#### **Purpose and Effect of the Consent**

The applicant is seeking the approval for severance of a surplus farm dwelling as they are surplus to the farm operation. The applicant owns abutting property and will continue to use the retained lands for agricultural purposes.

Severed Lands: The severed and retained lands dimensions are as follows:

Lot	Frontage	Area	Structures
Severed	140.21m	1.81 ha	Surplus Dwelling
Retained	64.52 m	20.59 ha	None

The retained lands have an area of approximately 20.59 hectares with approximately 64.52 metres of frontage along Morganston Road and are currently used for agricultural purposes. The proposed severed lands at 1580 Morganston Road contain an existing dwelling and barn structure that is surplus to the new owners and will continue to be used for residential purposes.

### Representation

Any person may attend the public meeting and make written and/or verbal representation either in support of or in opposition to the proposed consent. Please ensure your name and address are included as required for the public record.

# Please note that any information provided within written submissions may be made available to the public for review prior to the hearing.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Cramahe before the by-law is passed, the person or public body is not entitled to appeal the decision of the Committee of Adjustment of the Township of Cramahe to the Ontario Land Tribunal, and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

#### **Notice of Decision**

A copy of the decision of the Committee of Adjustment will be sent to the applicant, and to each person who appeared at the scheduled public meeting or made written representation and who has filed with the Clerk a written request for Notice of the Decision.
