# **Location of the Subject Lands**

The lands subject to the proposed by-law are located at 218 Orchard Road in the Township of Cramahe. A key map is attached showing the location of the subject lands.

## Purpose and Effect of the Temporary By-law

The subject lands are currently zoned Rural (RU). The purpose of the application is to renew a Temporary Use By-Law that is currently in place. The purpose of the temporary zoning is to permit (for maximum of 3 years) a petting zoo, dog park, and commercial parking lot associated with The Big Apple. The zoning is top be in place until such time as a permanent zoning can be put in place. #### Representation

Any person may attend the public meeting and make written and/or verbal representation either in support of or in opposition to the proposed Zoning By-law Amendment. Please note that any information provided within written submissions may be made available to the public for review prior to the hearing.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Cramahe before the by-law is passed, the person or public

body is not entitled to appeal the decision of the Council of the Township of Cramahe to the Ontario Land Tribunal, and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so
