



## **Heavy Equipment Mechanic – Part Time (Temporary Fulltime) Opportunity TRANSPORTATION DEPARTMENT**

The Township of Cramahe is located in the heart of Northumberland County, just over an hour's drive east of Toronto on the north shore of Lake Ontario.

The Municipality is seeking applications to fill the Heavy Equipment Mechanic position within our Transportation and Environmental Services Department. The position is governed by the Township's Collective Agreement with CUPE Local 5070 and will be scheduled for a minimum of 24 hours per week. (Salary rate is Grade 10, Step 1 \$38.37 per hour)

Reporting to the Transportation Manager and Assistant Manager, the position's responsibilities include:

- Proven mechanical abilities in hydraulics and electrical, including schematics and diagnostics
- Diagnosing defects in heavy duty equipment, including electrical and hydraulic issues
- Completing necessary repairs and adjustments
- Keeping detailed and accurate maintenance reports and documentation
- Operating Arc and Mig welders efficiently
- Knowledge and adherence to workplace safety policies and regulations
- Other mechanical repair work as assigned

Success in the position requires the ability to repair and maintain heavy trucks, earth moving and related construction equipment including road graders, backhoe/loader, gasoline and diesel-powered tractors, dump trucks, snow plough/sander and fire trucks. Travel to off-site locations and varied workdays may be required, as well as working in both indoor and outdoor settings.

The preferred candidate will possess a minimum Class G driver's license, completion of college/CEGEP/vocational or technical training, Ontario College of Trades 310S Automotive Service Technician and 310T Truck and Coach Technician certifications. A minimum of 5 years' experience as a Heavy Equipment Mechanic is required, along with a satisfactory criminal record.
