## **Location of the Subject Lands**

The lands subject to the proposed zoning by-law amendment are located at 209 King Street East and are municipally known as Concession 2, Part Lot 27, Township of Cramahe (Assessment Roll # 1411 012 030 15300). A key map is attached showing the location of the Subject Lands.

#### Purpose and Effect of the Zoning By-law Amendment

A Zoning By-Law Amendment was approved as a condition of Provisional Approval of a recent consent (Lot Line Adjustment) that conveyed a small section of land to 209 King Street East (File No. D10-RUT-14-24). The current proposed amendment is to place the transferred portion of land within a Holding (H) in order to address a condition of provisional consent concerning an Environmental Site Assessment (ESA).

#### Representation

Any person may attend the public meeting and make written and/or verbal representation either in support of or in opposition to the proposed Zoning By-law Amendment. Written submissions can be sent electronically to <a href="mailto:planning@cramahe.ca">planning@cramahe.ca</a> or can be dropped in the mail drop box at Town Hall at 1 Toronto Street, Colborne or faxed to (905) 355-2821. Please ensure your name and address are included as required for the public record. Please note that any information provided within written submissions may be made available to the public for review prior to the hearing.

If a person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Cramahe before the by-law is passed, the person or public body is not entitled to appeal the decision of the Council of the Township of Cramahe to the Ontario Land Tribunal, and may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal unless, in the opinion of the Tribunal, there are reasonable grounds to do so
